ARTICLES OF INCORPORATION
for

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. Name: The name of the corporation is FLOR CAL CHEMICAL BY DUTCH, INC. The address of the corporate office shall be 2885 S.E. 1st Court, Boynton Beach, Florida, FL 33435.

ARTICLE II. Duration: The period of this corporation's duration is perpetual.
