

ARTICLES OF INCORPORATION

OF



FLORIDA AIRCRAFT & BOAT PARTS & SALVAGE, INC.

Article I - Name

The name of this corporation is FLORIDA AIRCRAFT & BOAT PARTS & SALVAGE, INC.

Article II – Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.

Article III - Purpose

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

Article IV - Capital Stock

This corporation is authorized to issue 10,000 shares of \$1.00 par value common stock.

Article V – Preemptive Rights

Every stockholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which such stock already holds, shall have the right to purchase a pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
