Dolphin Management Properties, Inc.


SECOND: The following amendment to the articles of incorporation was adopted by the corporation:

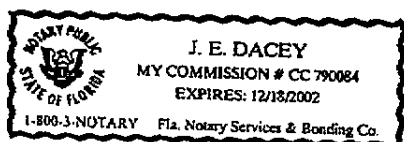


