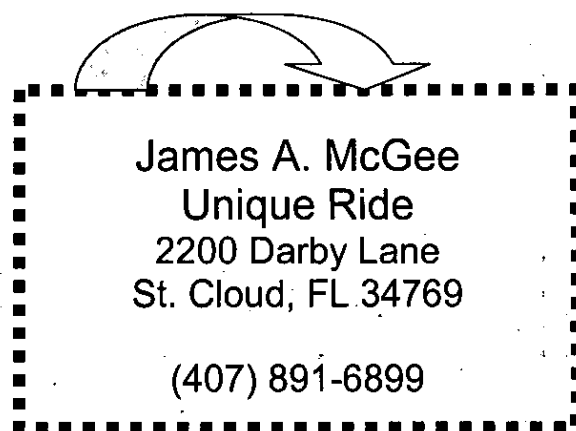

Unique Ride was incorporated 07/31/2000 and administratively dissolved 09/21/2001. The corporation would like to be reinstated retroactively. A check for \$450 is enclosed for annual renewal fee for years 2001, 2002 and 2003

We would also like to ask you to abate the penalty. The company was new and not familiar with the annual renewal process. We did not receive any bill for 2001. Since we did not know to expect one, we did not contact you. Subsequently, we moved and never received the UBR for 2002 either.

This came to light when our banker checked our status on the public database and discovered the corporation had been administratively dissolved. The management apologizes and would like to remedy this error.

Please consider our request for abatement of penalty and reinstatement of the corporation to active status. Thank you for your consideration.
