Article I - Name

The name of this corporation is: Konlin Enterprises, Inc.,

Article II - Duration

This corporation shall have perpetual existence.

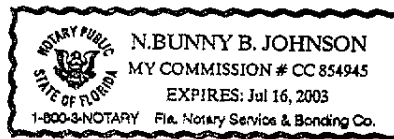
