**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF

Milam Howard Nicandri Dees & Gillam, P.A., pursuant to Section 607.1006, *Florida Statutes*, adopts the following Articles of Amendment to its Articles of Incorporation:


1. The name of the Corporation is Milam Howard Nicandri Dees & Gillam, P.A.
2. Amendments Adopted: Article I of the Articles of Incorporation of Milam Howard Nicandri Dees & Gillam, P.A. is hereby amended to read as follows:

**Article I
Name and Duration**
