
- First: The name of the corporation is Hayman Harper Corporation



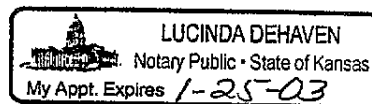
