ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION
OF AMERI-CHOR, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

The name of the corporation is AMERI-CHOR, INC. (hereinafter referred to as the "Corporation").
