Pursuant to Article of section 607-1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendments(s) adopted:

Amend Article III as follows:

Article III – The number of shares of stock that that the corporation is to have outstanding at any one time is 100 million (100,000,000) with a value of \$0.001 per share and classified as common shares.

SECOND: The date of the amendment is September 8, 2000.

THIRD: The amendment was adopted by the board of directors without shareholder action and shareholder action was not required.
