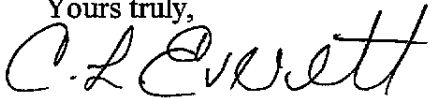

ARTICLE I. NAME

The name of this corporation is TOTAL OFFICE CONCEPTS, INC. and its initial place of business shall be 3745 Northwest 193rd Street Miami, Florida 33055.

ARTICLE II. NATURE OF BUSINESS AND POWERS
