ARTICLES OF INCORPORATION

ALLAHASSEE FI STATE The undersigned subscriber to these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

SPIRES ENTERPRISES, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted is:

- To engage in every aspect and phase of the business of cleaning construction sites 1. upon completion of building construction, and to engage in every aspect and phase of related businesses.
- To engage in every aspect and phase of the business of sale of health related products, and to engage in every aspect and phase of related businesses.
- To engage in every aspect and phase of the business of investing and reinvesting in real, tangible and intangible property.
- To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services, of every class, kind, and description; except that it is not to conduct a banking, safe deposit, trust, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, cooperative association, fraternal benefit society, state fair or exposition.

- To purchase the corporate assets of any other corporation and engage in the same or other character of business.
