Articles of Incorporation

FIRST: I, Richard H. Bernstein, whose post office address is 1761 W. Hillsboro Boulevard, Suite 318, Deerfield Beach, Florida 33442, being at least eighteen (18) years of age, hereby form a corporation under and by virtue of the General laws of the State of Florida.

SECOND: The name of the corporation (hereinafter called the "Corporation") is

FOUNTAINVIEW INVESTMENTS INC.

THIRD: The purposes for which the Corporation is formed are:

(1) To purchase, lease and otherwise acquire, hold, mortgage, convey and otherwise dispose of all kinds of property, both real and personal, both in this state and in any part of the world.

(2) To do anything permitted in the Florida Code, as amended from time to time.
