The undersigned, for the purpose of forming an S Corporation under the Florida General Corporation Act, does hereby adopt the following Article of Incorporation:

ARTICLE I

Name

The name of this corporation is: **EXPERT'S AUTO TECH, INC**

ARTICLE II

Duration

This corporation shall have a perpetual existence; commencing on the date these Articles are filed with the Secretary of State.

ARTICLE III

Purposes

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act in the fixing and repairing of both domestic and foreign automobiles, other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Florida Corporations Code.

ARTICLE IV

Capital Stock

This corporation is authorized to issue only one class of shares of stock which shall be designated Common Stock, \$1.00 par value; and the total number of shares which this corporation is authorized to issue is 4000.

ARTICLE V
