# ARTICLES OF INCORPORATION

The Undersigned, acting as incorporator of this corporation pursuant to Chapter 621 of the Florida Statutes, who is duly licensed to practice as a doctor of veterinary medicine, hereby forms a professional service corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

## Article I - Name of Corporation

The name of the corporation shall be Richard Rubinstein, P.A.

## Article II - Term of Existence

This corporation shall begin its corporation existence as of the 26th day of July, 2000, and shall exist perpetually.

## Article III - General Purpose

The general purpose for which this corporation is organized shall be:

To render professional veterinary services to the general public, and to do all things in connection therewith that are customarily done by veterinaries under the laws of the State of Florida, and to invest its funds in real estate, mortgages, stocks, bonds, and other tupes of investments, and to own real and personal property necessary for the rendering of professional services. The business of the corporation shall be limited to the foregoing activities.

# Article IV - Capital Stock

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is Seventy-five thousand (75,000) shares of common stock having a par value of ten cents (\$0.10) per share.

## Article V- Shareholder Restrictions

No one other than an individual who is duly licensed or legally authorized to render veterinary services in the State of Florida may own stock of this corporation. No shareholder of this corporation shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his stock. Any stockholder who becomes legally disqualified to render veterinary services shall sever all employment with and financial interest in the corporation. No shareholder of the corporation may sell or transfer his stock in this corporation, except to another individual who is eligible to be a shareholder of the corporation.

## Article VI - Initial Registered Office and Registered Agent

The initial street address of the registered office of this corporation in the State of Florida will be

move the registered office to any other address in Florida. The name of the initial registered agent

#### Article VII - Initial Board of Directors

- A. The initial number of Directors of this corporation shall be one (1).
- B. The number of directors may be increased or diminished from time to time by by-laws adopted by the shareholders, but shall never be less than one.
