the Board of Directors and the shareholders.

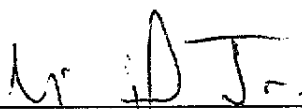
ARTICLE X - AMENDMENT

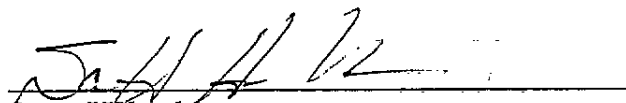
