ARTICLES OF INCORPORATION

OF

GLENDA MOCK INCORPORATED

I, the undersigned, hereby execute this document for the purpose of becoming a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is GLENDA MOCK INCORPORATED.

ARTICLE II - PRINCIPAL OFFICE
