ARTICLE I

SEURLTARY OF STATE TALLAHASSEE, FLORIDA

The name of this Company shall be " Internet Business World Corp."; the existence of this Company shall commence upon the filing of these articles of incorporation and shall continue perpetually unless dissolved according law.
