ARTICLE I

The name of this Company shall be "**Internet Business World Corp.**"; the existence of this Company shall commence upon the filing of these articles of incorporation and shall continue perpetually unless dissolved according law.

ARTICLE II

The company is being organized for the purpose of transacting any and all lawful business permitted under the laws of the State of Florida and the laws of the United States.

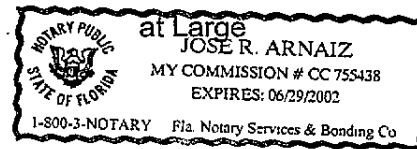
