## ARTICLES OF INCORPORATION

(A FLORIDA Professional Service Corporation)

#### ARTICLE I. NAME

The name of this corporation shall be JOHN P. DUNNE, DA. 10 EXCHANGE ESCROW CORPORATION.

#### ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the incorporator. This corporation's duration shall be perpetual.

#### ARTICLE III. PROFESSIONAL SERVICE CORPORATION

#### Section A. License

This corporation is specifically formed for rendering the same professional service to the public that any duly licensed Attorney, under the laws of this state, is authorized to render.

#### Section B. Powers

- 3. No contract, or other transaction of this corporation with any person, firm, or corporation, shall be affected by the fact that any director or officer of this corporation is in any way connected with such person, firm or corporation.

#### ARTICLE IV. PURPOSE

This corporation is being organized for the purpose of holding in escrow I.R.S. S. Code Section 1031 Funds awaiting reinvestment, and engaging in the transaction of any and all other business activities permitted under the laws of Florida and the United States Of America.

#### ARTICLE V. CAPITAL STOCK

This corporation shall have the authority to issue 100 Shares Common no par value shares of common capital stock.

#### ARTICLE VI. PREEMPTIVE RIGHTS
