**ARTICLE I.**

The name of the corporation is O.R TANS WORLD TRADING, INC.

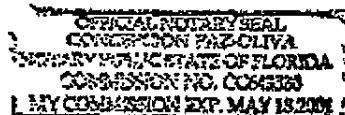

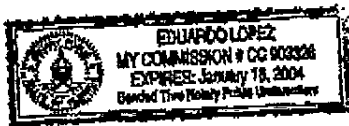
