

ARTICLES OF INCORPORATION OF M & GW ENTERPRISES, INC.



ARTICLE I

The name of the Corporation shall be M & GW ENTERPRISES, INC.

ARTICLE II COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Florida Department of State. This corporation's duration shall be perpetual.

ARTICLE III PURPOSE
