ARTICLE I - NAME

The name of this corporation is On Site Cleaning, Inc.

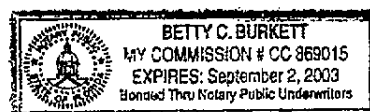


