The undersigned, for the purposes of foregoing a corporation under the Florida General Corporation Act, do hereby adopt the following articles if incorporation.

ARTICLE I Corporate Name & Address

The name of the corporation shall be Strongarm Pools of Broward, Inc. and the address is 6611 Winfield Blvd Suite 110 Margate, Fl 33063.

ARTICLE II Term of Existence

The duration of the corporation is perpetual, to be commenced with the filing of these articles of incorporation with the Department of State of the State of Florida.
