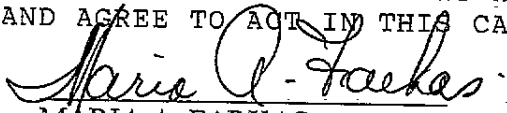
ARTICLE VIII
