ARTICLES OF INCORPORATION

I, the undersigned incorporator, for purpose of forming a corporation under the Florida Business Corporation Act, do hereby form a corporation and adopt the following Articles of Incorporation.

ARTICLE I -NAME

The name of the corporation is:

ARTICLE II - PURPOSE AND NATURE OF BUSINESS

This corporation is organized for the general purpose of transacting all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE III - INITIAL PRINCIPAL PLACE OF BUSINESS

ARTICLE VIII - VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE X - BY-LAWS

The power to alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE XI - INDEMNIFICATION
