The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

# ARTICLE I

The name of this corporation shall be The Furniture Store Of N. Ft. Myers Inc.

#### ARTICLE II

The general nature of the business, and the objects and purpose to be transacted and carried on, are to do any and all things herein mentioned as fully and to, viz., the corporation may engage in any activity of business permitted under the laws of business permitted under the laws of the United States and the State of Florida and shall possess all of the powers granted corporations under the provisions of Chapter 607, Florida Statues.

#### ARTICLE III

The authorized capital stock of this corporation shall be 7,500 shares of common stock having a par value of \$ 1.00 per share.

## **ARTICLE XI**

No director or officer shall be liable to the corporation or any of its stockholders for monetary damages for breach of fiduciary duty as director of officer, except with respect to:

- A breach of the director's duty of loyalty at the corporation or its stockholders, derived and improper personal benefits.
- 2. Acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law.
- 3. Liability under Section 607.144 of the Florida General Corporation Law, or
- 4. A transaction from which the director or officer derived an improper personal Benefit. The corporation shall indemnify to the fullest extent permitted by Section 607.014 of the Florida General Corporation Act, as amended from time to time, each person that such Section grants the corporation the power to indemnify.

## ARTICLE XII - By-Laws
