ARTICLE I

NAME. The name of this Corporation is: DESTINY MORTGAGE GROUP, Inc. and the initial address of the corporation is: 1528 N. Powers Drive, Orlando, Florida 32818.

ARTICLE II

BUSINESS AND ACTIVITIES. This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida. The initial purpose of this corporation is to operate as a Mortgage Brokerage Business.

ARTICLE III

CAPITAL STOCK. 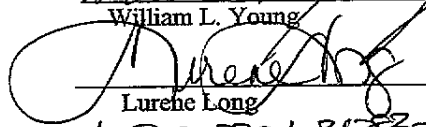
ARTICLE XI

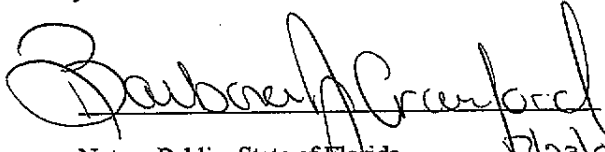

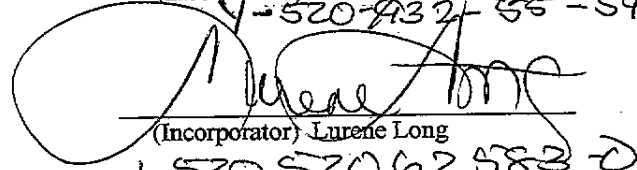

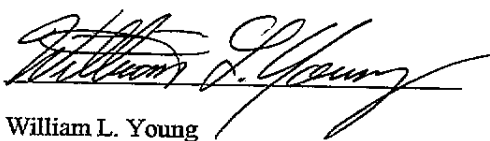
