**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as Incorporator of a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation for such Corporation:

**FIRST**

The name of the Corporation is Woody's & Blue Dog Surf, Inc.






