ARTICLES OF INCORPORATION

<u>OF</u>

JVL ACQUISITION, CORP.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be JVL Acquisition, Corp.

ARTICLE II. EXISTENCE

The period of existence of the corporation shall be perpetual.

ARTICLE III. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 2112 Mariner, Springhill, FL 34609.
