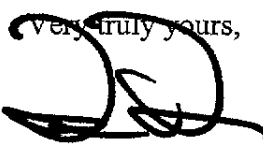

ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Sandi's Mane Attraction, Inc.

ARTICLE II

The existence of the Corporation shall begin on August 1, 2000.

ARTICLE III

The street address of the principal office of the Corporation is 200 West Walker Drive, Keystone Heights, Florida 32656.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000 shares, with a par value of \$10.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 200 West Walker Drive, Keystone Heights, Florida 32656. The initial registered agent for the Corporation at that address is Sandra Lee Groves.
