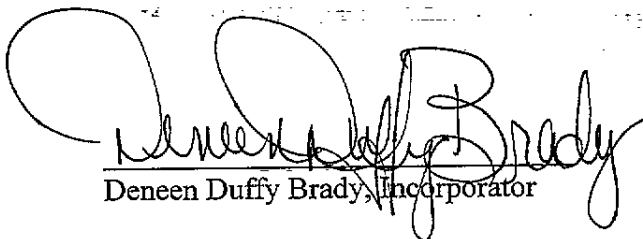
ARTICLE VII - BY-LAWS
