ARTICLES OF INCORPORATION

ARTICLE I

NAME AND ADDRESS

The name of the corporation is: The address of the corporation is: Coastal Media Magazines, Inc. 12685. Timber Pine Tr. Wellington, FL 33414



PURPOSE

- 1. To conduct general business related to offering Advertising services and supplies to the general public. To include, publishing newsletters, newspapers, magazines, directories and internet services.
- 2. To purchase, buy, sell, and exchange any production or office equipment and machinery, and do all things incidental to the accomplishment of the foregoing purposes.

- 4. To engage in any activity or business permitted under the laws of the United States and the State of Florida.



ARTICLE III

CAPITAL STOCK
