ARTICLES OF INCORPORATION OF CAFE2, INC.

The undersigned, desiring to form a corporation (the "Corporation") under the laws of Florida, hereby adopts the following Articles of Incorporation effective August 4, 2000:

ARTICLE I CORPORATE NAME

The name of the Corporation is Cafe2, Inc.

ARTICLE II PURPOSE

The Corporation shall be organized for any and all purposes authorized under the laws of the State of Florida.

ARTICLE III PERIOD OF EXISTENCE

The period during which the Corporation shall continue is perpetual.
