Pursuant to your conversation last week, with my attorney, Armando Rubio, please accept this letter as a formal request for the reinstatement of ToDiveFor.Com, Inc. as well as a processing of the merger filings for South Beach Divers, Inc. and ToDiveFor.Com, Inc.

As discussed, the Plan of Merger and Articles of Merger were forwarded to the Division of Corporations in early April of this year. Pursuant to numerous telephone conversations with the Division, the various documents were completed as instructed by the Division and a check in the amount of \$43.75 was forwarded along with them. Furthermore, as ToDiveFor.Com, Inc. was being merged into South Beach Divers, Inc., we were told that the filing of a UBR for the former was not required.

Notwithstanding our following of the Division's instructions, the Articles and Plan were returned on May 17<sup>th</sup> with a request for an additional \$35. Immediately upon receipt of this correspondence, we again contacted the Division to request some sort of clarification. At that time, we were told that the original amount of \$43.75 was in fact sufficient and that the filing would be processed. When asked, we were told that no additional action was necessary on our part as the filing would be finalized and the merger would be processed by the Division.

Unfortunately, last week, we received a Notice of Administrative Dissolution or Revocation for ToDiveFor.Com, Inc., requesting a reinstatement fee totaling \$750.00. As you can imagine, we were very surprised at receiving this notice, as our last communication with the Division confirmed that

ToDiveFor.Com, Inc. had in fact been merged with South Beach Divers, Inc. and no UBR filing was needed.

After numerous attempts over the last week at contacting someone in the Division, we had the good fortune of speaking with you. As you explained, apparently the "hold" on the filing because of the \$35 balance referenced above was never removed, causing the merger filings to not have been processed.

As stated above, the filings and checks sent to the Division were done so according to the Division's instructions. With regards to the merger documents, the \$43.75 was the amount calculated by the Division which we were told to forward with the Articles and Plan of Merger. The only reason the additional \$35 was not forwarded was because, as detailed above, we were told by the Division that the documents had in fact been processed and that some sort of mistake had occurred in the calculating of the amount due, resulting in the mailing of the May 17<sup>th</sup> letter.

Accordingly, in order to reinstate ToDiveFor.Com, Inc. and allow the filing of the merger documents to go through, pursuant to your instructions, enclosed please find:

- 1.) A check in the amount of \$150 for the processing of ToDiveFor.Com, Inc.'s Uniform Business Report;
- 2.) A completed and signed Application for Reinstatement for ToDiveFor.Com, Inc.;
- 3.) A copy of the Division of Corporations' May 17, 2002 letter;
- 4.) Signed original Articles of Merger and a Plan of Merger pertaining to both South Beach Divers, Inc. and ToDiveFor.Com, Inc.; and
- 5.) A check in the amount of \$35 for the outstanding balance on the above-referenced merger filings.
