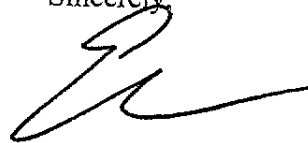

The mailing address of the initial principal office of the corporation is 6616 Kingman Trail, Tallahassee, Florida 32308.

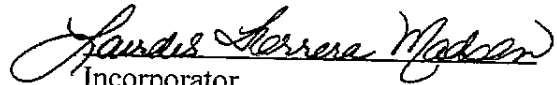
Article VIII - Amendment of Articles
