**ARTICLES OF INCORPORATION
OF
GUILLERMO J. FERNANDEZ-QUINCOCES, P.A.**

The undersigned, desiring to form a Florida Corporation under the Professional Services Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation is GUILLERMO J. FERNANDEZ-QUINCOCES, P.A. ("Corporation").

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

The initial principal place of business of the Corporation is 200 South Biscayne Boulevard, 41ST floor, Miami, Florida, 33131.

**ARTICLE III
COMMENCEMENT OF EXISTENCE**

The existence of the Corporation will commence on the date of filing with the Department of State.

**ARTICLE IV
PURPOSE**

ARTICLE V
AUTHORIZED SHARES

The maximum number of shares that the Corporation is authorized to have outstanding at any time is Ten Thousand (10,000) Shares of common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed by the Board of Directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 200 South Biscayne Boulevard, 41st Floor, Miami, Florida, 33131, and the name of the Corporation's initial Registered Agent at that address is Guillermo J. Fernandez-Quincoces, Esq.

ARTICLE VII


**ARTICLE IX
BYLAWS**

Thereafter, every amendment shall be approved by the Board of Directors, proposed by them to the shareholders, and approved at a Shareholder's meeting by the holders of a majority of the shares entitled to vote on the matter or in such other manner as may be provided by law.
