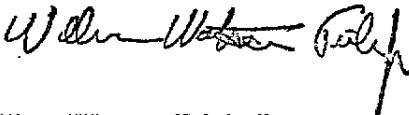

**ARTICLE 1: CORPORATE NAME:** The name of this corporation is First Choice Coin Laundry, Inc.

**ARTICLE 2: PRINCIPAL OFFICE:** The street address of the initial principal office of this corporation is 2630 NW 8th Court, #1, Ft. Lauderdale, Florida 33311.

**ARTICLE 3: MAILING ADDRESS:** The initial mailing address of this corporation is 2630 NW 8th Court, #1, Ft. Lauderdale, Florida 33311.
