There shall be one initial officer of the corporation. The name, address and title of the officer is:



ARTICLE VII:


FISCAL YEAR

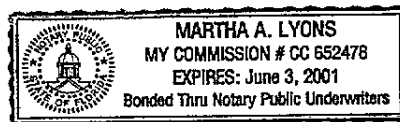




