**ARTICLE I**

The name of the corporation is NYROCA, INC. and its mailing address and principal place of business is 500 East Broward Boulevard, Suite 1950, Fort Lauderdale, FL 33394.

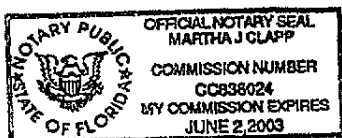
