

The undersigned, for the purpose of forming a for-profit corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

**ARTICLE ONE
NAME**

The name of the Corporation is Lorraine Farm Supply, Inc.

**ARTICLE TWO
DURATION**

The term of existence of the Corporation is perpetual.

**ARTICLE THREE
PURPOSE**

The purpose for which the Corporation is formed is to engage in farm supply and may, in addition, engage in any and all lawful businesses for which corporations may be incorporated under the Florida General Corporation Act.
