ARTICLES OF INCORPORATION

ARTICLES OF INCORPORATION of LARRY NULL INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, pursuant to Chapter 607 and 621 Florida Statutes, do hereby adopt the following articles of incorporation

ARTICLE I

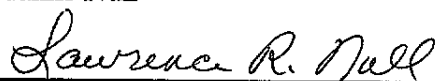

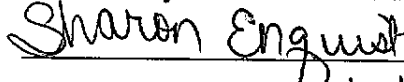
