**ARTICLE I - CORPORATE NAME.**

**ARTICLE II - POWERS.**

**ARTICLE V - REGISTERED AGENT.**

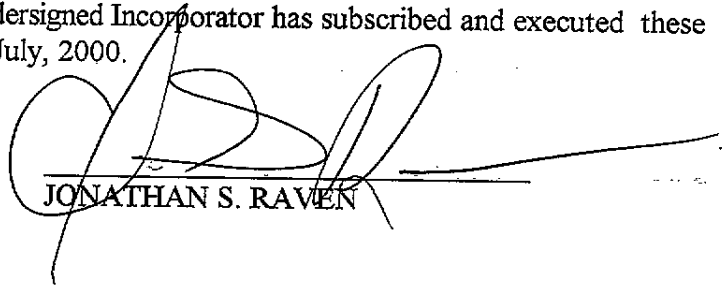

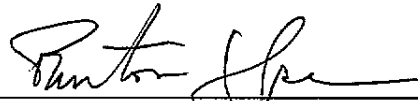
