The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

Article I

NAME

The name of the corporation is THE BIRDS' PALACE, INC. and the principal address shall be 2800 Biscayne Boulevard, Suite 500, Miami, Florida 33137.

Article II

DURATION

The corporation shall exist perpetually. Corporate existence shall commence upon filing by the Department of the State.

Article III
