ARTICLES OF INCORPORATION

<u>OF</u>

BURNT STORE MEDICAL, INC.

The undersigned does hereby associate himself for the purpose of forming a corporation under the laws of the State of Florida under the corporate name BURNT STORE MEDICAL, INC., and hereby sets forth and declares:

<u>CHARTER</u>

ARTICLE I

The name of the corporation shall be BURNT STORE MEDICAL, INC., located at Punta Gorda, County of Charlotte, State of Florida, and the mailing address shall be the same.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The authorized capital stock which the corporation may issue shall be 10,000 shares of \$1.00 par value common stock, which shall be nonassessable and held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine.

ARTICLE IV

The corporation shall commence business on filing with the Secretary of State.

<u>ARTIÇLE V</u>

The corporation shall have perpetual existence, except that the same may be dissolved, as provided by law.

ARTICLE VI

The principal place for the transaction of its business shall be 3020 Matecumbe Key Road, Unit 101, Punta Gorda, County of Charlotte, in the State of Florida. The amount of indebtedness or liability to which the corporation at any time may subject itself shall be unlimited.

ARTICLE XI

ARTICLE XII

This corporation elects to have preemptive rights. Each shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE XIII

The initial Bylaws of this corporation shall be adopted by the Board of Directors. The Bylaws may be amended from time to time by either the shareholders or the directors. The shareholders may amend, alter, or repeal any Bylaw adopted by the directors. Nothing herein contained shall create liability in the events above described or prevent the authorized approval of such contracts in any other manner permitted by law.
