ARTICLES OF INCORPORATION  
OF  
NASSBERG DIABETES ASSOCIATES, P.A.  
A FLORIDA CORPORATION

The undersigned, acting as incorporators of a Florida Professional Service corporation under the Florida Professional Service Corporations and Limited Liability Companies Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the Corporation is NASSBERG DIABETES ASSOCIATES, P.A.

ARTICLE II

DURATION

The Corporation shall have perpetual existence.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of the rendering of professional services related to the practice of medicine. In addition the corporation shall have the right to invest its funds in real estate, mortgages, stocks, bonds, or any other type of investments and shall also have the power to own real or personal property necessary for the rendering of professional services.

CAPITAL STOCK

The Corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock.

COMMENCEMENT OF EXISTENCE

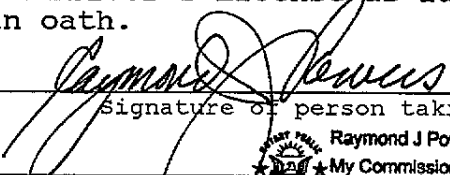
The Corporation shall be deemed to commence existence on August 8, 2000.
