The undersigned hereby executed these Articles of Incorporation for the purpose of begoming a corporation under and by virtue of the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges of immunities of a corporation for profit.

- (c) To manufacture, purchase, or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description; except that it is not go conduct a banking, safe deposit, trust, insurance, surety; express, railroad; canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.
