OF

ARTICLE I - NAME

The name of this Corporation is Advanced Studies Development Corporation.

ARTICLE II - NATURE OF BUSINESS

This Corporation will engage in the consulting business, but may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III - CAPITAL STOCK

ARTICLE IV - TERM OF EXISTENCE
