ARTICLES OF INCORPORATION

of

O.D.S. AIR CONDITIONING, INC.

I, the undersigned, subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associate myself to form a Corporation under the Laws of the State of Florida.

ARTICLE I NAME

The name of this Corporation is: O.D.S. AIR CONDITIONING, INC.

ARTICLE II NATURE OF BUSINESS

The general nature of business and the object and purposes to be transacted and carried on are: AIR CONDITIONING SERVICES. 

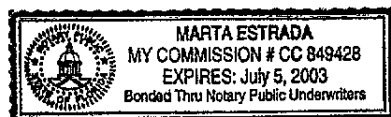
