

**ARTICLE I - NAME**

The name of this corporation is ADVANCED DATA SOLUTIONS AND CONSULTING, INC.

**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III - DURATION**
