ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the Corporation shall be: **ANDREW I. ALEMAN, P.A.**, and the principal place of business is: 8433 West Okeechobee Road, Hialeah Gardens, FL 33016.

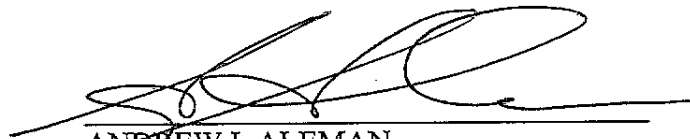

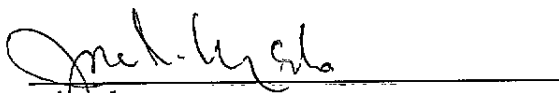
